Ruby, Katherine Johnson in accordance with the recommendation of the Planning Commission with the additional stipulation under item #12 that this Special Use Permit approval will allow for the applicants home occupation to allow the instruction of CPR/AED First Aid classes for up to 6 participants on a limited basis on Saturday's from 8am till 5pm and by appointment during the week not later in operation than 10pm at the property as it is proposed by the Applicant, were made by Aldermen Bill Poletti/Pat Baeske.
