The regular meeting of the Fairview Heights City Council was called to order at 7:00 P.M. by Mayor Mark T. Kupsky in the Municipal Complex, 10025 Bunkum Road, Fairview Heights, IL with the Pledge of Allegiance and Invocation by City Clerk Karen J. Kaufhold.

ROLL CALL

CONSENT AGENDA

Proposed Resolution No. 29-'18 passed on 8 yeas and 2 absent.

Proposed Resolution No. 30-'18, a Resolution authorizing the Mayor to enter into a contract on behalf of the City of Fairview Heights with DMS Contract, Inc. to provide services for the Fairview Heights Oil and Chip Program. Motion made by Alderman Vickers. Seconded by Alderman Poletti.
